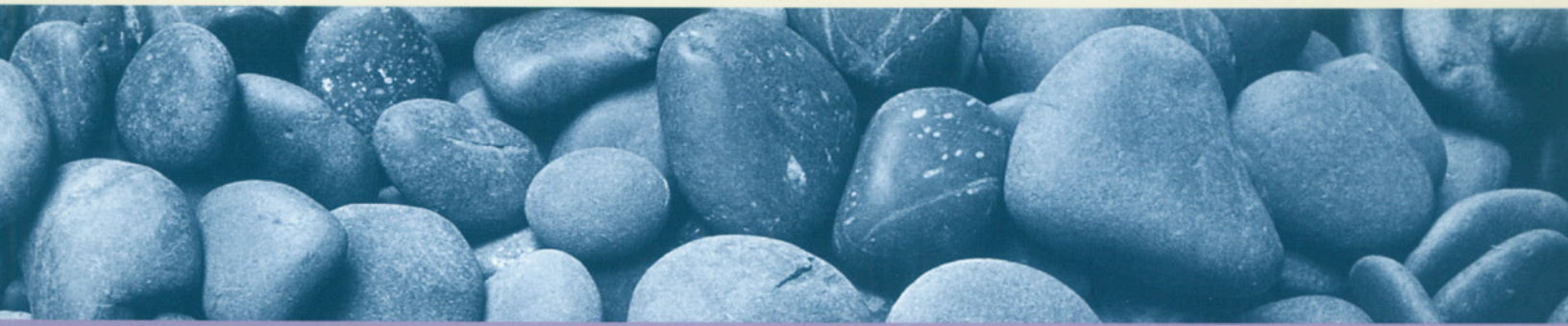

Mr Harris received a JD from Columbia University School of Law in 1982, where he was a Harlan Fiske Stone Scholar and certified with honours by the Parker School of Foreign and Comparative Law. Mr Harris received an AB magna cum laude from Cornell University in 1977, where he was a Cornell University college scholar of the College of Arts & Sciences.
