The Firm: Consistently positive feedback reinforces Kirkland's position at the top of the antitrust table. "This is one of the very best firms I've worked with, and the first firm I'd call on where tough and complex antitrust issues are involved," enthused one client, echoing market opinion of this Chicago behemoth. Commentators agree that Kirkland's antitrust capabilities took root in the firm's celebrated litigation practice, and the antitrust team is still best known for its "phenomenal strength in litigation." Kirkland recently acted for Aon in a case that amply demonstrated this skill; a consolidated federal putative antitrust and RICO class action, brought by insurance policyholders who alleged an industry-wide conspiracy to stifle competition and allocate insurance policies based on broker commissions. Another distinctive feature of the firm is the deep bench of lawyers: sources describe a "large team where each and every lawyer is bright, thorough, efficient and collaborative." This strength of manpower ensures that clients are "keen to retain the firm on matters that require a high level of attention."

The Lawyers: Jim Mutchnik (see p.1057) uses his "great intelligence, litigation skills and breadth of experience" to achieve "excellent results." Involvement in some of the biggest and most important antitrust work demonstrates the firm's prominent position on the Illinois legal landscape; for example, this year the team defended BASF against allegations that manufacturers conspired to fix the price and allocate customers and nationwide markets for certain urethanes. Clients appreciate this team of "bright and knowledgeable lawyers" that is supported by "ample resources."

The Lawyers: Senior lawyer Lee Abrams is univer-

sally regarded as "excellent" in antitrust matters. Sources agree that the firm benefits greatly from his experience and expertise. Andrew Marovitz is "a formidable opponent." Described as "bright and solid," he is "strong in terms of his substantive knowledge, and has a lot of credibility with judges." Mark McLaughlin is "a roll-up-your-sleeves, get-to-thepoint, practical adviser," declare satisfied clients. Robert Finke also receives positive feedback.

to the practice. "Fantastic litigator" John Treece (see p.1069) receives accolades for his excellent understanding of the pharmaceutical industry. Commentators marvel at his "understanding of the rules, and his ability to put the issues into a legal framework in a pragmatic way."

Clients/Work Highlights: The firm advised MAP Multiple Listing Service (MAP) in an investigation by the Antitrust Division of the Illinois Attorney General's Office. The investigation focused on MAP's rules regarding the availability of participants' listings to populate the Internet sites of other MAP participants. The firm also acted for the National Association of Realtors (NAR) in a case where the DOJ challenged NAR's policies regarding the display of real estate listings on the Internet. Further work includes representing Toda Kogyo in a federal case alleging price-fixing in the magnetic iron oxide industry.

The addition of Roxane Busey and Tom Campbell in 2005 strengthened the practice, and the firm has been involved in some important merger work over the past year, recently advising Bayard on the acquisition of two competitors in automated metering for electrical utilities. Though compact, this team's solid and far-reaching network of international connections adds to its credentials—clients frequently cite this global reach as one of the firm's key attributes.

The Lawyers: Known for her work in the healthcare industry, Roxane Busey (see p.1034) receives praise from numerous sources. One peer noted: "If I needed an antitrust counselor, I'd be very, very confident with Busey. She is a brilliant lawyer, bright and experienced." Clients are satisfied with the service they receive from Tom Campbell (see p.1034), describing him as "very knowledgeable and responsive."

Clients/Work Highlights: The firm furnished advice to Hospira on the FTC investigation of Hospira's acquisition of Mayne Pharma and defended the National Resident Matching Program in an antitrust class action.

The Firm: Although this national giant now has offices reaching as far afield as Shanghai, the firm remains justifiably proud of its Chicago roots. Authorities in the market assert that the team of "excellent lawyers" here drives the Chicago antitrust practice from strength to strength, and clients are

delighted with the service they receive. One explained: "The team here is terrific in terms of intellectual expertise, and is incredibly skilled in trial work—this is a great combination, and we were very pleased with the results achieved for us." Commentators draw particular attention to the firm's "very strong healthcare antitrust practice," but are quick to add that the firm has expanded its remit in recent years, and as a result "diversity is now another feature of the firm." The group has capabilities in a wide range of areas. Recently the firm represented Koch Industries and its subsidiaries in defending an ongoing nationwide class action alleging antitrust violations in the sale of sulfuric acid.

The Lawyers: Joel Chefitz (see p.1035) "is very knowledgeable and insightful, which is a great combination."
