- Representing U.S. oil refiner in six climate change lawsuits filed by California counties and municipalities claiming that a number of oil, natural gas, and coal companies are responsible for sea level rise attributable to greenhouse gas emissions. Plaintiffs claim substantial infrastructure and real property injuries have arisen from the alleged defective nature of defendants' fossil fuel products, from defendants' placement of those products into the marketplace without sufficient warnings, and from an alleged campaign of misinformation that undermined public understanding of those dangers.

creditors of foreign sovereign parent corporation seek to hold affiliates liable based on alleged transfers in excess of \$2 billion; obtaining dismissal of one client in district court and successful outcome for second client in the Third Circuit.
